AND 2024/25 RAIL ACCESS TARIFFS UNTIL FURTHER NOTICE****PURPOSE**

This Notice hereby informs interested persons and the rail industry stakeholders that the Minister of Transport has approved an extension of the application of the 2024/25 Network Statement for the Transnet Rail Infrastructure Manager (TRIM) and the 2024/25 Rail Access Tariffs until further notice.

BACKGROUND

The first Network Statement and Rail Access Tariffs for the period from 1 April 2024 to 31 March 2025 were finalised and published on the Transnet website on 20 December 2024, subsequent to a consultation process that was led by the Interim Rail Economic Regulatory Capacity (IRERC).

The draft 2025/26 Network Statement and Rail Access Tariff Proposal documents were published for public consultation by TRIM on 7 February 2025 on the Transnet website. The IRERC conducted a virtual Information Gathering Session on 25 February 2025 and is currently in a process of analysing written comments received to ensure that comments raised by stakeholders are addressed appropriately.

The Minister of Transport has granted approval to extend the application of the 2024/25 Network Statement for TRIM and the 2024/25 Rail Access Tariffs until further

notice. Once the Minister has approved the revised Network Statement and Rail Access Tariffs for the 2025/26 financial year, stakeholders will be informed accordingly.
